Our cookie usage policy presents the types of cookies we apply when you visit or use the website www.unicreditleasing.ro ("The Site").

1. What is a cookie?

A cookie is a small file (often of text type) stored on your computer or device when visiting the Site by UniCredit Leasing Corporation IFN S.A. (located in Bucharest, 1st sector, 1F Expozitiei Bvd, , 1st floor, 7th floor, and 8th floor, Romania, a company administered in a dualistic system, registered in the Commerce Registry under the no. J40/3396/2002, fiscal registration code RO 14600820, registered in the General Registry of BNR under no. RG-PJR-41-110031/02.08.2007, with a subscribed and paid capital of 90,989,012.79 RON). Cookies are installed upon the request issued by a web server to a browser (e.g., Internet Explorer, Chrome) and are entirely "passive" (they don't contain software programs, viruses, or spyware and can't access the information on the user's hard drive). A cookie consists of 2 parts: the name and the content or value of the cookie. The lifespan of a cookie is determined; technically, only the web server that sent the cookie can access it again when the user returns to the website associated with that server. Cookies are standard for most current browsers and are widely used to enable online services and increase their efficiency and to provide service providers with information about your experiences while browsing the site. When you use these online services again, your browser sends the previously stored cookies back to the online service. In this way, the online service recognizes and remembers important information about you that helps it customize and facilitate the experience it offers you, for example, by remembering your saved preferences.

2. Why are cookies used?

We use cookies to automatically record certain information about how you use the Site and navigate within it. This Site only uses technical functional cookies that are essential for providing the services specifically requested by website visitors. Without them, the web pages cannot function and cannot provide the requested services. A detailed presentation of the cookies strictly necessary for the functioning of the Site is shown below:

As the administrator of the Site, UniCredit Leasing Corporation IFN S.A may store technical functional cookies on your device.

4. How can I manage cookies?

You can set the browser you are using to block necessary cookies, or you can delete them after the browsing session ends. However, we would like to point out that, in such a situation, the websites you visit (including the Site) may not work properly.

5. Policy updates

Occasionally, we may modify this policy to reflect technological, legislative, or operational changes, as well as for any other reason we deem necessary or appropriate. Any such changes will take effect upon publishing the updated policy on www.unicreditleasing.ro. We advise you to frequently consult the "last update date" mentioned above (available on www.unicreditleasing.ro) to ensure that you are up-to-date with the latest update of the policy and can better understand the nature of your interactions with the Site.
